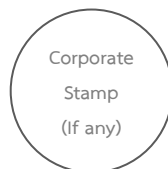
1. ThaiBMA reserves the right to approve or deny any request to use API Services at its sole discretion.

The Applicant hereby acknowledges and agrees that the API Services requested for trial are supplemental services associated with and reliant upon the Association's iBond service system. Therefore, for the trial of the said services to be deemed complete and compliant with the Association's established criteria, the Applicant shall be obligated to comply with the following conditions

- 5.1 For Existing iBond Users: The Applicant must submit evidence confirming its current status as a user of the iBond service, appended to this Application Form.
- 5.2 For Non-Existing iBond Users: The Applicant must concurrently submit an application form for the trial use of the iBond service along with this Application Form for API Services trial use. Strict compliance with this requirement is mandatory.
